- 1. <u>CONSIGNMENTS:</u> Please bring your consignments in baskets or boxes. (I.e. no bags or hangers). <u>Each consigner is limited to 20 items per visit</u>. Consignors should remain in the store while items are evaluated. Any items not selected for sale will be returned to the owner. If something is found to be defective after acceptance it will be subject to donation. All items consigned are subject to sale at anytime. Sales will be scheduled around the holidays and/or the changing season.
- 2. <u>PICKING UP UNSOLD ITEMS:</u> Your items must remain in the store the full 43-45 days. Anything remaining after your pickup date becomes the property of the Shoppe. Pickups may be made at anytime during normal business hours. Customers may pickup one or two days before items goes 50% off. It is your responsibility to remove your items from display.
- 3. <u>CLOTHING</u> must be in "like new" condition, clean, pressed, free of hair and without wrinkles. Clothes must be in style and fashionable. Please do not remove the tags from garments. The Shoppe has the right to refuse any item or garment due to overstock or condition.
- 4. **OTHER ITEMS** Curtains, bedding, tablecloths, etc. must be marked with size when consigned. We do not accept rummage sale items. Any battery operated item requires a working battery included.

The Shoppe assumes no responsibility for loss, theft, or damage. Lucy's Nearly New reserves the right to terminate a contract at anytime. To collect the proceeds of your sales come to the Shoppe anytime during business hours. Special arrangements can be made for a mailed payment. All money not picked up by the consigner within a year is forfeited and account will be closed.

Dear Consignees;

First of all, I want to thank each and every one of you for your continued business throughout the years. Your continued support has made Lucy's Nearly New Shoppe a unique shopping experience for the Sturgis community for over 30 years.

To continue Lucy's success, we are becoming more and more selective with the merchandise consigned into the store.

Clothing items brought into the store must be: clean, pressed and folded nicely with no tears or stains. Clothes must be in style, fashionable, and in season. Please bring your items in boxes or baskets. No items in plastic bags will be accepted. Knick-knacks and household items will be clean and in good condition. *No* items that have previously been rummage sale items will be accepted.

We ask that you stay in the store while we look through your items, so that the items we cannot accept will be returned to you. Please do not use the dumpster located outside Lucy's to throw the items you do not want and we will not consign. Once in a great while, we do miss an item that has a hole or tear and place it on the floor for resale. If we do find such an item, we will pull it from the floor and dispose of the item.

In late 2008, legislation was passed that greatly impacted consignment shops like Lucy's across the country. The Consumer Product Safety Improvement Act was passed making it illegal to sell any children's product that exceeds 100 parts per million of lead. While resellers, like Lucy's, are not required to test for lead we are held responsible if we sell something that exceeds the limit. The first fine for non-compliance is \$100,000. Due to the severity of this penalty, we will not be accepting any products (toys, furniture, jewelry, clothing, etc.) for children under 12 years of age.
